

Searching for articles or eBooks

Databases

The first option is to search for your topic directly in a database. The advantage of this is that you don't need to search for the full-text after finding an article that's relevant. On the other hand, you may need to perform that same search in several databases.

BI-accessible databases are indexed in [here](#).

Advantage: Full-text is immediately available to view / download.

Disadvantage: Only searches the journals available in the database being searched.

Academic Search Engines

Using an academic search engine is a convenient way to search across many databases and journals at once, and while academic search engines sometimes link directly to full-texts (especially [Open Access](#) materials), you will often need to find the full-text using a [research database](#) once you have the citation.

Advantage: The ability to search thousands of journals at once.

Disadvantage: Doesn't always offer full-text of citations.

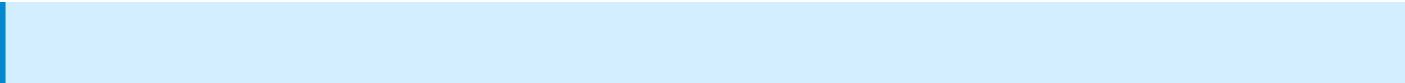
BASE

BASE (Bielefeld Academic Search Engine) is a multi-disciplinary search engine to scholarly internet resources, created by Bielefeld University Library in Bielefeld, Germany. As of 2022, it had indexed over [280 million documents from over 9000 sources](#).¹

CORE

CORE (**CO**nnecting **RE**positories) is a service provided by the Knowledge Media Institute based at The Open University, United Kingdom.¹

Finding full-text with citations



After finding a citation with an academic search engine or via the bibliography of an already acquired source, it's time to find the full-text.

Option 1: Search [EZB](#) to see if BI has access to the journal

Option 2: Search the [BAU Discovery System](#) to see if the journal is available from BAU

Option 3: Use the [BAU EZProxy Bookmarklet](#) to immediately see if full-text is available via BAU

Discovery Systems (Combined Search)

Discovery systems try to combine the two search methods described below by searching across many databases at once AND providing full-text access. Barbaros Library provides a discovery system that can be used to search most of their collections at once. [Click here for more information.](#)

Advantage: Searches many databases at once and provides access to full-text.

Disadvantage: Only searches the collections of one institution and cannot be integrated with all databases.

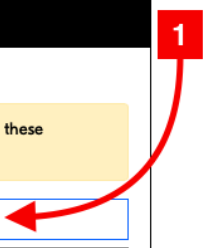

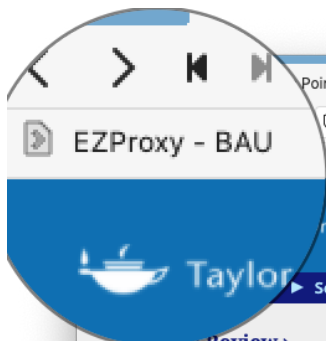
BAU EZProxy Bookmarklet

This bookmarklet no longer works. As of July 2026, BAU has moved remote-database authentication from EZProxy to OpenAthens. The bookmarklet on this page prepends the old proxy address, which has been decommissioned; **using it will not sign you in.** Please remove it from your bookmarks bar. For current instructions, see **how to access research databases using OpenAthens.**

How it works

If you search BAU databases directly, you are asked to provide login credentials to gain 'proxied' access to resources. In cases where you go directly to a publisher's site without having logged in ("proxied"), you will not be recognised as having access. For these cases, the EZProxy Browser Bookmarklet will allow you to log in without first going back to the BAU web site. A bookmarklet is like a browser extension but more lightweight and can be used on any browser that supports bookmarks, including mobile browsers.

Once added you will see **EZProxy - BAU** in your menu bar. Click on **EZProxy - BAU** and the proxy prefix is added to the URL and the work, if BAU has access, will be accessible.

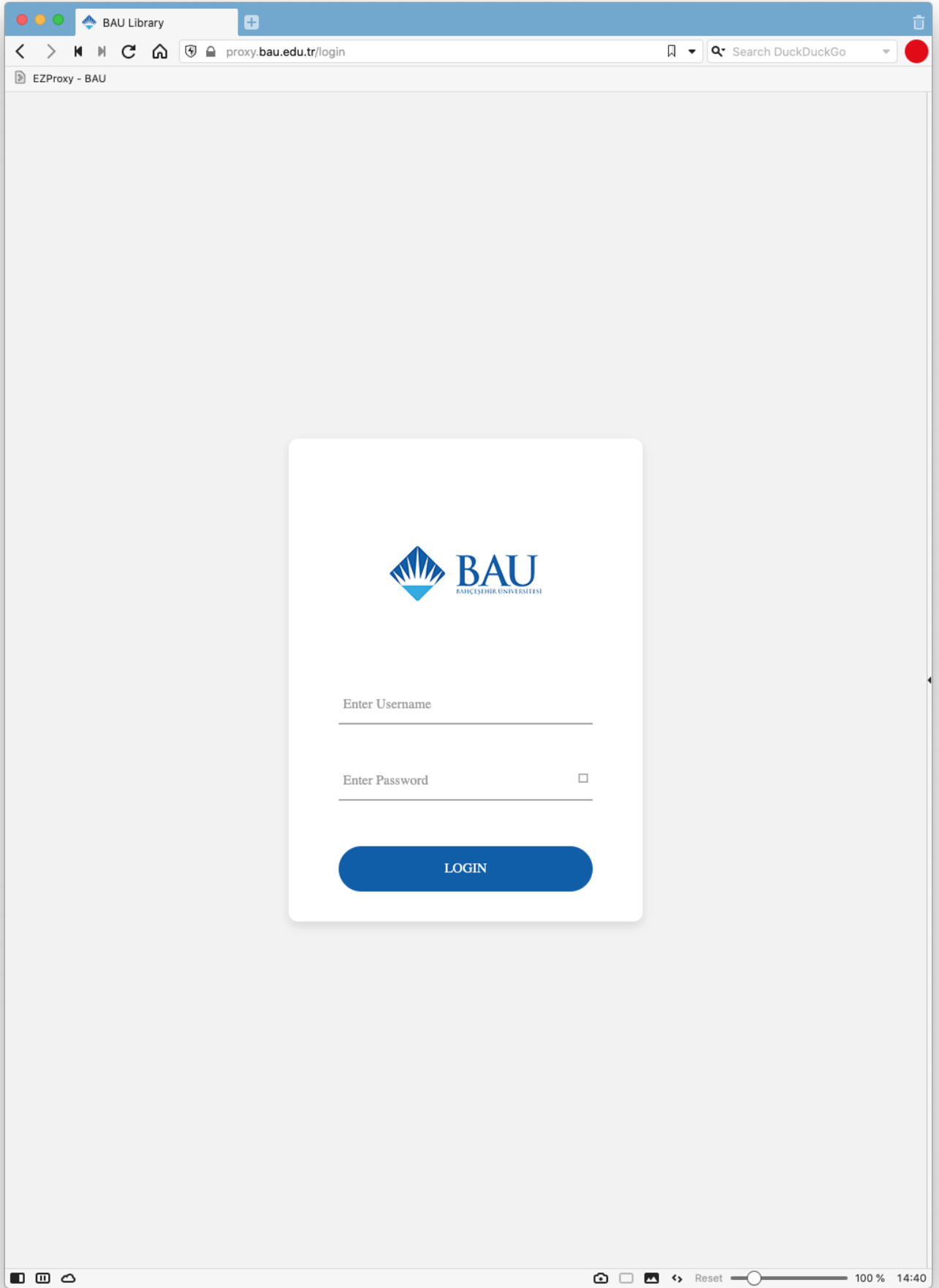

Introduction

Installing the Bookmarklet

Installing the EZProxy bookmarklet varies depending on browser. In general, add the EZProxy link to an always visible Bookmarks or Favorites Toolbar, usually by dragging it into the toolbar. Below are specific instructions for some of the more common browsers.



- From the View menu, choose "Toolbars" and "Bookmarks Toolbar" and "Always"
- Right-click on the Bookmarks Toolbar and select "Add Bookmark..." with the following code as the URL:

- From the View menu, choose "Always Show Bookmarks Bar"
- Right-click on the Bookmarks Bar and select "Add Page..." with the following code as the URL:

```

Mobile devices



- Select and copy this JavaScript code

javascript:void(location.href=%22http://proxy.bau.edu.tr:2048/login?url=%22+location.href)

- Open web browser on your device to any page and make a bookmark (it doesn't matter which one because the name and content will be edited). To make a bookmark tap the share icon on the page and choose "Add to Bookmarks".

- Edit the bookmark by tapping the bookmark icon and then Edit. From the Edit view, find the bookmark you made and tap the right arrow to edit
- Edit the name of the bookmark to **EZProxy - BAU** (or whatever works to describe the bookmark for you) and then paste the JavaScript code into the web address space (delete web address first). Choose Done to complete the process.
- The next time you're browsing a BAU-provided resource on your mobile device off-campus, simply click or tap the **EZProxy - BAU** bookmark you created to sign in for BAU-provided access to that resource.

Android devices



- Create a bookmark named **EZProxy - BAU** (or name of your choice) following all the steps described for iOS devices.
- For **non-Chrome Android mobile browsers**: click or tap the Proxy bookmark you created to sign in for BAU-provided access to the resource.
- for **Chrome mobile browser**: start typing the name of the bookmark in the address bar of the browser (e.g., start typing EZProxy - BAU if that is what you named it), then select the bookmark when it appears in the drop down menu to run it.

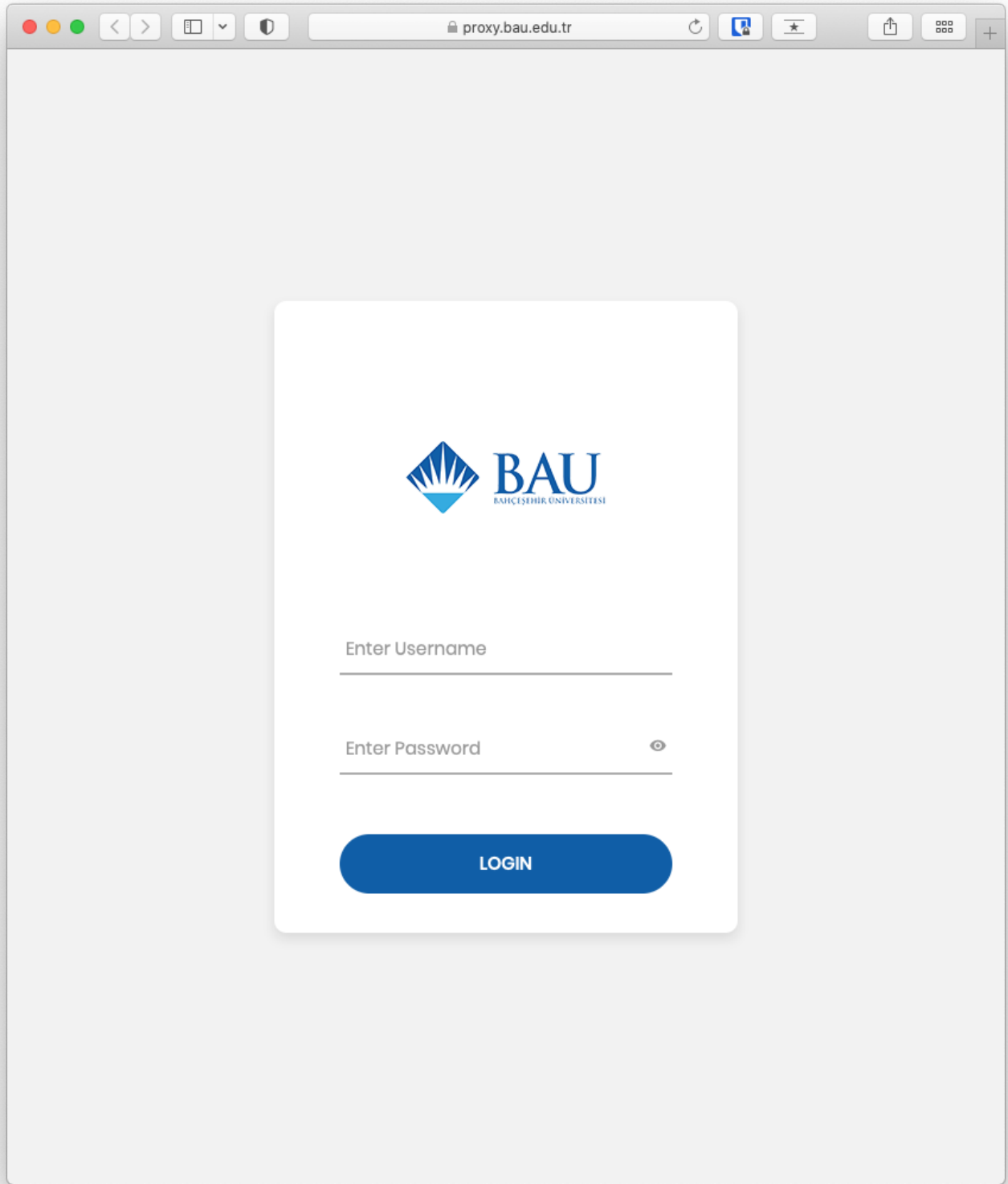
Accessing BAU Resources

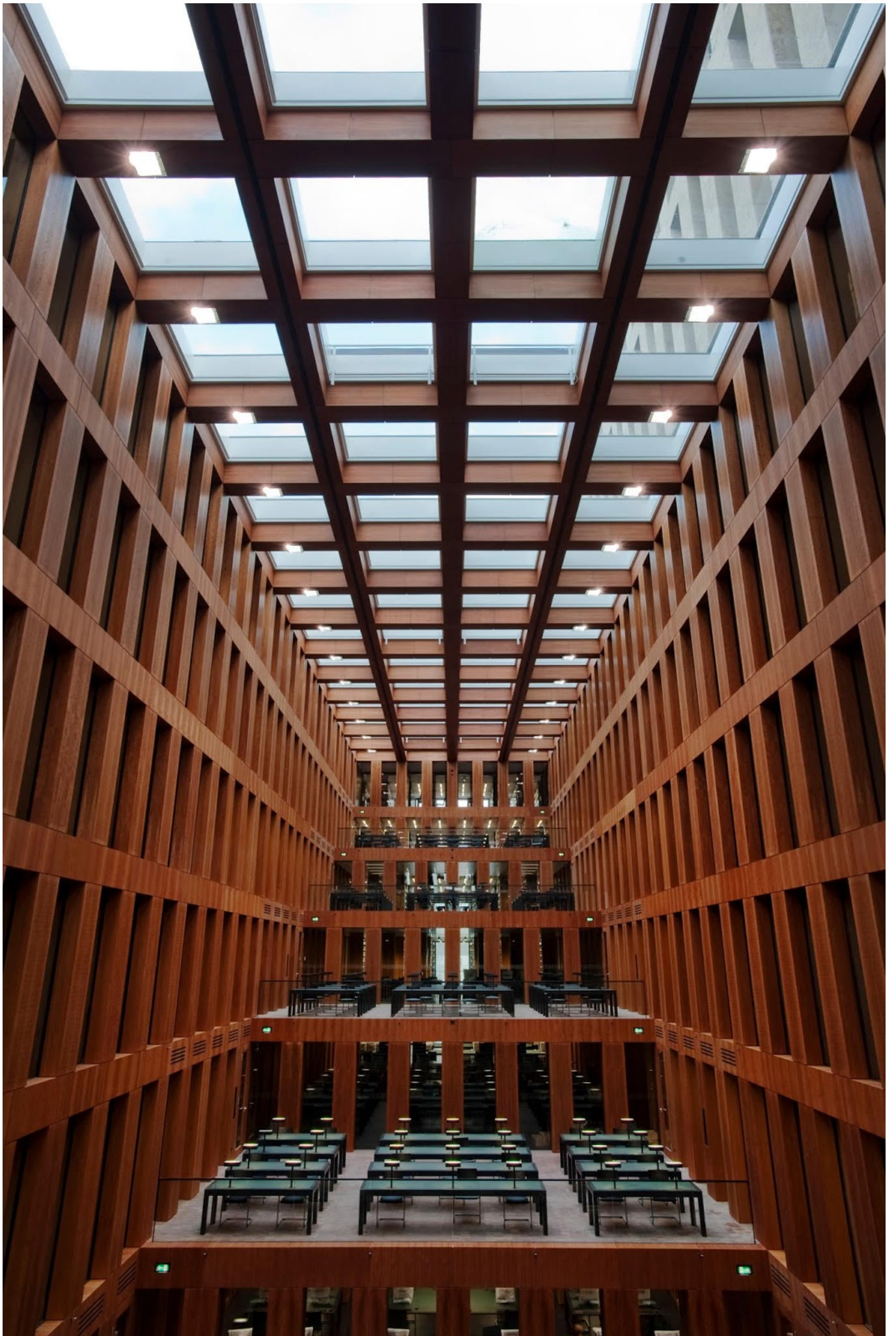

Open Access (OA) Journals & Articles

What is Open Access?

Open Access (OA) refers to the free, immediate, online availability of research outputs such as journal articles or books, combined with the rights to use these outputs fully in the digital environment. **Open access journals** are scholarly publications whose articles are available and reusable worldwide free of charge and without restrictions immediately upon publication.

Unlike traditional subscription-based journals, OA content is open to all readers with no access fees. Most open access journals publish articles under [Creative Commons](#) licenses, allowing for broader reuse and distribution while maintaining proper attribution.

Key Benefits of Open Access:

- **Increased visibility and impact** of research through wider accessibility
- **Enhanced citation frequency** due to unrestricted access
- **Accelerated knowledge dissemination** without paywalls
- **Global accessibility** regardless of institutional subscription status

Directory of Open Access Journals (DOAJ)

The **Directory of Open Access Journals (DOAJ)** is the premier resource for discovering quality open access journals. Launched in 2003, DOAJ now contains over 21,000 journals covering all areas

of science, technology, medicine, social sciences, arts, and humanities.

Key Features:

- Community-curated list of peer-reviewed OA journals
- Comprehensive coverage across all disciplines and languages
- Quality standards for inclusion (peer review, licensing, copyright policies)
- Serves as the starting point for OA journal searches

Tips for Authors and Researchers

Finding Quality OA Journals:

1. **Use DOAJ** as your primary search tool for legitimate OA journals
2. **Check indexing status** in major databases (Scopus, Web of Science)
3. **Verify peer review processes** and editorial board credentials
4. **Review licensing terms** to understand reuse rights

Funding Considerations:

- Many OA journals use **Article Processing Charges (APCs)** to cover publication costs

- Some journals operate on **diamond open access** (free for both authors and readers)
- Check institutional funding support for OA publication fees
- Consider **green open access** through institutional repositories as an alternative

Quality Indicators:

- Inclusion in DOAJ directory
- Clear peer review policies
- Transparent editorial processes
- Proper ISSN registration
- Appropriate licensing (typically Creative Commons)
